Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, this is to inform that the Board of Directors of the Company at its meeting held on Friday, 17<sup>th</sup> December, 2021, has approved the proposal for change Registrar and Share Transfer Agent ('RTA') of the Company from KFin Technologies Private Limited (KFintech) to Alankit Assignments Limited (Alankit) w.e.f. 1<sup>st</sup> January, 2022 or any subsequent date as approved by the Chairman & Managing Director or Company Secretary of the Company.

The formalities for change of RTA relating to documentations, shifting of electronic connectivity and transition of records are in process. However, KFintech will continue to act as RTA of the Company till such time the database and the electronic connectivity is shifted to Alankit and until the requisite confirmations received from National Securities Depository Limited and Central Depository Services (India) Limited.

The change of RTA was decided in order to facilitate continuation of more efficient shareholders' service.
